ANNOUNCEMENT

Re: Graduation consideration & submission of International English and MOS certificates for graduation requirements 2024

The Saigon International University formally informs students about the graduation consideration and the deadline for submission of International English and MOS certificates for graduation requirements 2024 as follows:

- 1. Requirements for graduation consideration and recognition (applied for students of course 13):**
 - Have no criminal prosecution or suspension by the time of graduation consideration.
 - Accumulate enough credits for specified programs.
 - Achieve a cumulative grade point average of the entire course of 2.00 or higher.
 - Obtain the certificates of national defense and physical education.
 - English and Information Technology requirements (see sections 4. and 5.)
 - Obtain the certificate of participation in club activities issued by SIU.
 - Meet the requirements of the SIU swimming training course.
 - Tuition fees and other fees must be paid.
- 2. Graduation consideration time**
 - Graduation consideration for the first time: August 26, 2024
 - Graduation consideration for the second time: October 25, 2024
 - Graduation consideration for the third time: December 25, 2024
- 3. Deadline for submission of International English and MOS certificates**
 - The deadline for submission of certificates for the first graduation consideration is August 15, 2024
 - The deadline for submission of certificates for the second graduation consideration is October 16, 2024
 - The deadline for submission of certificates for the third graduation consideration is December 16, 2024
- 4. International English certificate:**
 - 4.1. The corresponding certifications for each major:**
 - 4.1.1. For the programs taught in the Vietnamese language:**
 - Students majoring in English Language: pass the English Language Proficiency Test organized by the Saigon International University with the result equivalent to Level 5 on the Vietnamese Foreign Language Proficiency Framework or submit an international English certificate equivalent to C1 level according to the Common European Framework of Reference for Languages (CEFR) (TOEIC 850, IELTS 7.0; TOEFL iBT 80).
 - Students majoring in Economic Law: submit TOEIC 550 of ETS - The US.
 - Students of other majors: submit TOEIC 500 of ETS - The US.
 - 4.1.2. For the programs taught in English language:** Students are required for a minimum TOEFL score of 79 iBT or an IELTS score of 6.5.

4.2. Submission of Certificates:

The **original certificate (Official Score Certificate, Test Taker Score Report, Original Test Report Form)** is not accepted. Only **Score Certificate (duplicate), Additional Test Report Form, and TOEFL iBT Score Verification Confirmation** are accepted by SIU in order to keep graduation records without returning them to students.
